



TERMS OF SERVICE

This Terms of Service should be read by you (the "User" or "you") in its entirety prior to your use of Gamient Club. Please note that the Terms of Service constitutes a legally binding agreement between you and Gamient Club (referred to herein as "Gamient Club", "us" or "we"), which owns and operates the Internet Site and games found at www.gamientclub.com

By registering an account and making bids you confirm that you agree and understand the Game Rules described on the Gamient Club Internet Site.

DEFINITIONS

Capitalized terms that are used in this Terms of Service will have the following meanings:

Account: personal profile created by the User on the Gamient Club Internet Site.

Balance: User's game balance; the amount of cryptocurrency User has available for bidding.

Bid: amount of cryptocurrency User is willing to set for a single game within a Service.

House Edge: commission, payable to Gamient Club per each winning bet within a provided Service.

Cryptocurrency: peer-to-peer digital currency accepted by the Service (e.g. Bitcoin, Ethereum).



Games: games, managed by Gamient Club and provided within Gamient Club Internet Site.

Game Rules: list of rules and description of the gameplay of the Games provided by Gamient Club.

Faucet: option that allows User to get a free amount of cryptocurrency.

Internet Site: website of Gamient Club at www.gamientclub.com

Internet Site Content: all the text, graphics, video, sound and software elements of the Internet Site and the Games.

Max Win: is a maximum sum of any single Bid and winnings generated by this Bid.

Prohibited Jurisdictions: territories of states, where online game is prohibited or restricted.

Prohibited Use: prohibited by this Terms of Service and applicable legislation actions in regards of the Gamient Club

Service: providing access to the Games managed by Gamient Club within the Internet Site.

Withdrawal Fee: commission, payable to Gamient Club to cover expenses of the network for processing a transaction.

User: individual, who uses the Internet Site and agreed to the Terms of Service.



GRANT OF LICENSE

Subject to Terms of Service contained herein, Gamient Club grants the User a non-exclusive, personal, non-transferable right to use the Service on your personal computer or other device that accesses the Internet in order to access the Games available and described on the Internet Site.

The Service is not for use by:

individuals under 18 years of age;

individuals under the legal age of majority in their jurisdiction;

individuals accessing the Service from jurisdictions from which it is illegal to do so.

Gamient Club is not able to verify the legality of the providing services in each jurisdiction and it is the User's responsibility to ensure that their use of the Service is lawful.

The term Gamient Club, its domain names and any other trademarks, or service-marks used by Gamient Club are solely owned by Gamient Club

USER'S ACCOUNT

User has the right to have an account within the Internet Site. After first login, you'll be supplied with the automatically created account ready to play. To finalize the account creation you should enter your email and password. You can, and you are strongly recommended to, change the given password from time to time.

If you wish to start making bids, you must deposit cryptocurrency into your account from a source of which you are the only legitimate owner. After deposited amount is confirmed, it may be used to make bids.

You may request withdrawal of cryptocurrency from your account, as long as your deposits have been confirmed.

- A deposit is considered as confirmed, when a transaction has:
 - 1 confirmations for Bitcoins (BTC);
 - 2 confirmations for Ethereum (ETL);
- To make withdrawal, click the button "Withdraw", write an address on which you want to withdraw related cryptocurrency and its amount.
We have the following limits for all requested withdrawals per day, combined is less than 3 BTC per 24 hours, will be paid instantly;
is equal to or more than 3 BTC per 24 hours, will be paid within three (3) working days due to providing security verification.

Gamient Club shall not have any responsibilities for any delays and losses that may occur in accordance with cryptocurrency network malfunctions.

Gamient Club reserves the right to block any account without any notice due to any suspicious or malicious activity or if it was inactive for the last six (6) months



GAMIENT CLUB RIGHTS

Gamient Club reserves the right to assign this Terms of Service, in whole or in part, at any time without notice. The User may not assign any of his/her rights or obligations under this Terms of Service.

Gamient Club management reserves the right to cancel or reject any bet. Gamient Club management follows all bets and financial operations on each account.

CRYPTOGAMES MAY SUSPEND, TERMINATE, MODIFY OR DELETE ACCOUNTS AT ANY TIME FOR ANY REASON OR FOR NO REASON, WITH OR WITHOUT NOTICE TO YOU.

Accounts terminated by Gamient Club for any type of abuse, including without limitation a violation of the Terms of Service, the Game-specific Rules, will not be reactivated for any reason. For purposes of explanation and not limitation, most account suspensions, terminations and/or deletions are the result of violations of these Terms of Service, a Game-specific Rules. Gamient Club may stop offering and/or supporting the Service at any time.

You are aged 18 or over and that you are not currently self-excluded from any Crypto gaming site or gaming premises and that you will inform us immediately if you enter into a self-exclusion agreement with any provider.

PROHIBITED USE

The Internet Site is intended solely for the User's personal use. The User is only allowed to wager for his/her personal entertainment and may not create multiple accounts for the purpose of collusion and/or abuse of Internet Site.

The User shall not transmit cryptocurrency to the address provided by Gamient Club for the deposit purposes from a shared wallet or any other address not solely controlled by the User as any amounts sent back to the initiating address may not be properly deposited to the User.

It is prohibited to share your account access details to third-parties. The User is responsible for his or her login and password safety.

All bids should be processed using Gamient Club' software. It is prohibited to use any other or additional software to use Gamient Club service.

It is prohibited to exploit any vulnerability of BTC,ETL or Gamient Club for personal gain.
It is prohibited to use double-spend transactions.

It is prohibited to deposit and withdraw cryptocurrency without making actual bids.

It is prohibited to spam, write in capital letters, use offensive words and post advertising in emails to administration and/or customer service team of Gamient Club



It is prohibited to post false and/or offensive information about Gamient Club on external resources (forums, blogs, social networks).

Individuals located in or residents of the states where online Crypto game is prohibited are not permitted make use of the Service. For the avoidance of doubt, the foregoing restrictions on engaging in real-money play from Prohibited Jurisdictions applies equally to residents and citizens of other nations while located in a Prohibited Jurisdiction. Any attempt to circumvent the restrictions on the play by any individual located in a Prohibited Jurisdictions, is a breach of this Terms of Service. An attempt at circumvention includes, but is not limited to, manipulating the information used by Gamient Club to identify your location and providing Gamient Club with false or misleading information regarding your location or place of residence. It is your responsibility to determine the law that applies in the location in which you are present. You should ensure that you will be acting legally in your jurisdiction in using the Service, and you represent, warrant and agree that you will do so.

TERMS OF SERVICE TERMINATION

GDPR compliance

Starting from the 6th of May 201 we comply with General Data Protection Regulations. The General Data Protection Regulation (“GDPR”) is a privacy regulation. The GDPR aims to strengthen the security and protection of personal data in the EU and harmonize EU data protection law.
